



PRIVACY INFORMATIVE REPORT

Protection of Personal Data. European Directives 95/46/EC and 2002/58/EC

According to the requirements of the European directives 95/46/EC and 2002/58/EC, we hereby inform you that SAURO s.r.l. is in possession of your personal and fiscal data, which were obtained either directly from you, or through intermediary subjects, or from public lists. The above mentioned data are necessary for the correct management of the contractual relationships.

SAURO s.r.l. is the controller of the processing of your personal data; the related information can be processed in paper form, by automatic means, or by telecommunication means for contractual or law requirements as well as to allow the correct management of commercial relationships.

The provided email addresses can also be used by the company for forwarding of advertising material concerning services similar to those of the existent commercial relationships.

In case of failure to supply your personal data, if not obligatory, the controller will evaluate and will determine, each time, the consequent decisions, that will be related to the importance of the required data, with respect to the requirements of management of the commercial relation.

For the above mentioned purposes, data may be communicated also in Italy and/or in foreign States, but exclusively to the following third parties:

- credit institution
- collecting agencies
- credit insurance agencies
- commercial information agencies
- professionals and consultants

In such cases, the involved bodies will be bound to observe the privacy requirements of personal data.

The data subject can exercise all the rights listed in the referred directives (including the rights of: access, updating, rectification, integration, erasure, blocking, objection). In case of erasure, blocking and objection of the data processing, this will result in the impossibility for SAURO s.r.l. to maintain the existent contractual relation with the concerned data subject.

Processing and protection of personal data [Privacy code]

Right of access to the personal data and other related rights

1. The data subject has the right to obtain from Sauro (the controller) confirmation as to whether or not data relating to him/her are being processed, or undergoing processing, and to obtain communication to him/her in an intelligible form.

2. The data subject has the right to obtain information about:

a) the source of the personal data concerning him/her and the specific circumstances in which the data are collected;

b) the purposes of the processing;

c) the logic involved in any automatic processing of the data (i.e. using information technology means);

d) the identity of the controller and of his representative, if any;

e) the recipients or categories of recipients to whom the data are disclosed.

3. The data subject has the right to obtain:

a) the rectification, updating or integration, in particular because of the incomplete or inaccurate nature of the data;

b) the erasure or blocking of data the processing of which does not comply with the provisions of this Directive;

c) notification to third parties to whom the data have been disclosed of any rectification, erasure or blocking carried out in compliance with (b), unless this proves impossible or involves a disproportionate effort.

4. A data subject has the right to object, fully or partially:

a) if legitimated, to the processing of personal data concerning him/her, even though they are relevant to the purpose of the collection;

b) to the processing of personal data concerning him/her, for purposes including promotional mailings, direct sales, market researches or commercial communications.
